This report provides a review of Council's financial performance against the adopted budget year to date.







Note 1: Queensland Treasury Corporation (QTC) requires Council to hold minimum cash of four months expenditure for prudential management purposes. For TRC, this is approximately \$19M for the next four months.

Note 2: Represents grant funds that are received in advance of project completion. These funds are constrained for specific projects.

Loan Borrowings

- ➤ The borrowings balance as at 29th of February total \$4.7M. An additional loan of \$11M to support the delivery of water infrastructure works was approved, however has not yet been drawn down.
- > The total of the existing loan balance equates to approximately \$359 per rateable property.






