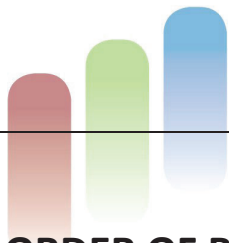

Public attendance at Council Meetings is now permitted. The Council Meeting will be will be streamed live, recorded and published on Council's website for viewing by the public.

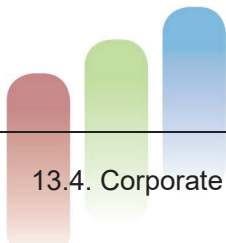
