  - A financial contribution towards the upgrade of the Davies Road and Malanda Water Supply Schemes (Water Supply Contribution).
- 2. The method of calculation and the supporting documents for the water supply contribution proposed by officers be provided to the applicant for their comment.
- 3. A report be tabled at the Ordinary Council meeting on Thursday 25 May 2023 that sets out the proposed terms of an Infrastructure Agreement that includes but is not limited to the effect of the rezoning deed, the per lot infrastructure charge, the water supply contribution, and payment terms and conditions.

The Planning Committee note the report to be tabled at the Ordinary Council meeting of Thursday 25 May 2023 will recommend approval of a Negotiated Decision Notice for RAL22/011 based on reasonable and relevant conditions, and will recommend Council delegate authority to the CEO to finalise any and all matters associated with the Infrastructure Agreement and the Water Supply Contribution on the terms set out in the report.
